

PERSONAL DATA PROCESSING TERMS – CONTACT FORM

By pressing the "**SEND A MESSAGE**", after entering the name, surname, e-mail address, subject and content of the message, you contact the operator via the contact form **-Lead Media s. r. o.**, with registered office: Karpatská 3091/6, 811 05 Bratislava - Staré Mesto district, ID number: 47 726 601, company registered in the Commercial Register of the District Court Bratislava I, section: Sro, file no.: 98621/B (hereinafter referred to as "**operator**").

The purpose of processing personal data: processing your inquiry delivered to the operator via the contact form.

Scope of processed personal data: name, surname, subject and content of the message, e-mail address.

Legal basis: Art. 6 par. 1 letter f) REGULATIONS OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL (EU) 2016/679

of April 27, 2016 on the protection of natural persons in the processing of personal data and on the free movement of such data, which repeals Directive 95/46/EC (General Data Protection Regulation) - legitimate interest of the operator. The operator has a legitimate interest in processing the personal data entered by you in the contact form for the purpose of processing your inquiry.

The period of processing of personal data is for the period necessary to fulfill your inquiry/request.

You have the right to object to the processing of personal data based on the legitimate interest of the operator. You can exercise this right in the following ways:

- by email sent to the operator's email address: polgari@leadmedia.sk
- by sending a written request to the address of the operator's headquarters with the text on the envelope "GDPR - withdrawal of consent e-commerce contact form".

The operator hereby informs you of the following:

- Personal data will be processed by the operator, who can be contacted by e-mail at the address: polgari@leadmedia.sk or in writing at the address: Lead Media s. r. o., Karpatská 3091/6, 811 05 Bratislava – Old Town district,
- Personal data will be processed on the basis of the legitimate interest of the operator in accordance with Art. 6 par. 1 letter f) of the General Data Protection Regulation,
- Personal data will be provided to the following recipients: subjects to whom the operator provides personal data on the basis of the law, professional consultants and advisors who are bound by a legal or contractual obligation of confidentiality,
- Personal data will be kept for the period determined by the operator and will not be processed for any purpose other than the one for which it was obtained.
- As a data subject, you have the right to request from the operator access to personal data concerning you, the right to their correction or deletion or restriction of processing, as well as the right to data portability in the case of automatically processed personal data,
- As a data subject, you are entitled to object to the processing of personal data,
- As an affected person, you have the right to file a complaint with the supervisory authority, which is the Personal Data Protection Office of the Slovak Republic,
- Cross-border transfer of personal data to a third country does not take place,
- The operator does not perform automated decision-making or profiling.
